"Log Submission Instructions:

1) Fill out your name, call and other information

2)Identify the total number of QSO's made

3) Identify the total # of distinct zip code pairs

(i.e. if you worked 3 stations while stationary from 16001, just list that zipcode once)

If you were operating mobile, count the distinct PAIRS of zipcodes worked (i.e. you operated

from 16001 and worked 2 stations in 15044 and you operated from 16002 and worked 3 stations from Ohio

4) Power output: if you operated below 10W the whole time, multiply score by 3

5) You can work the Same Station on all bands for points (ie: Same Station, Same zip code for total of 4 points)

6) If you operated between 10 and 50W the whole time, multiply score by 2
